Start of Construction on a 14 MW PV Power Plant in Ishinomaki (Miyagi)

juwi Shizen Energy Inc. (headquarters: Hongo, Bunkyo Ward, Tokyo, Japan; Representative Directors: Masaya Hasegawa and Raghuram Natarajan; hereinafter referred to as "juwi Shizen Energy") has received an order for the EPC (engineering, procurement, and construction) of a solar power plant called the Ishinomaki Numazu Photovoltaic Power Plant with an output of approximately 14 MW (DC, direct current) from Ishinomaki Kizuna GK – a company invested by the General Electric (GE) group company GE Energy Financial Services and Trina Solar Limited.

This power plant will use the 220,000 m² site of the former golf course in Miyagi prefecture's Ishinomaki city. Its annual generated energy output is projected to reach approximately 16,000 megawatt hours (16 million kilowatt hours), which is the equivalent to the annual amount of power consumed by 4,400 ordinary homes. The power it generates will be sold to Tohoku Electric Power Co., Inc. under the country's Feed-in Tariff (FIT) for renewable energy.

Trina Solar Japan Energy Co., Ltd. (headquarters: Hamamatsucho, Minato Ward, Tokyo, Japan; Representative Director: Carlos Garcia Garcia), a wholly-owned subsidiary of Trina Solar, is in charge of development and management for this project, while juwi Shizen Energy is responsible for EPC. Also, juwi Shizen Energy Operation Inc. (headquarters: Hongo, Bunkyo Ward, Tokyo, Japan; Representative Directors: Kumiko Isono and Raghuram Natarajan) will be responsible for O&M (operation and maintenance). The construction method will aim to install a large number of panels in a limited area and will thus employ platform dimensions and construction techniques suitable for the soil type and sloped surfaces.

juwi Shizen Energy was established in 2013 as a joint venture between Shizen Energy Inc. (headquarters: Arato, Chuo Ward, Fukuoka City, Fukuoka Prefecture, Representative Directors: Ken Isono, Kenji Kawado, and Masaya Hasegawa; hereinafter referred to as "Shizen Energy"), whose activities include the development of and securing of funding for renewable energy power plants, and juwi AG, a company headquartered in Germany that is involved in development and EPC for renewable energy around the world. As well as being involved in Shizen Energy's development projects, juwi Shizen Energy also takes orders for EPC-only construction projects and at the end of May 2016 completed construction of a large-scale photovoltaic power plant on a former golf course in Japan's Iwate prefecture that has an output of approximately 25 megawatts (DC). juwi Shizen Energy shall henceforth continue to leverage the knowledge and experience it has accumulated through its global operations and aim to contribute to the increased use of renewable energy and the construction of a sustainable society both in
