Shizen Energy Inc. (hereinafter referred to as "Shizen Energy") issued the 4th unsecured corporate bond "SDGs Support Private Placement Bonds" which Resona Bank, Limited (hereinafter referred to as "Resona Bank") is an underwriter as of September 25, 2019.

The financing amount by issuing the bonds will be applied to the operating funds for the development of new businesses for renewable energy power generation.

The system of this "SDGs Support Private Placement Bonds" is to support to achieve SDGs by Resona Bank contributes 0.1% of the total issued amount to SDGs related organizations.
