Shizen Energy Concludes Solar Farm Agreement for 17 locations in Brazil for a Total of 33.4 MWP

Shizen International Inc. (Shizen International), an international development and asset management company of renewable energy power plants, has concluded a solar farm agreement for 17 locations in Brazil for a total of 33.4 MWp to be completed within 2022. Fazsol Energias Renováveis (FazSol), a joint venture between Shizen Energia do Brasil Ltda (Shizen Brazil) and Brazilian real estate developer Espaço Y, has concluded this agreement with Órigo Energia, the leading distributed solar power generation company in Brazil.

The solar farms will be constructed in three regions (Distrito Federal, Minas Gerais, Ceará) and the generated power will be supplied through a remote net-metering system*1 to Órigo Energia customers. Órigo Energia currently supplies energy to about 35,000 customers with the energy generated on their solar farms. This agreement was concluded on December 31st, 2021, and the construction is scheduled to be completed by November, 2022.

With this addition of 17 solar farms, Shizen Energy group and Espaço Y have now collaborated together on a total of 25 renewable energy projects in Brazil.

Rodolfo Molinari, CBO at Órigo Energia commented "It has been quite important to Origo to build partnerships as the one developed with Shizen. The agreement will potentialize Origo's mission: to democratize clean energy access in Brazil. "

Bruno Suzart, Shizen's country manager in Brazil commented "This project is a symbol of our commitment to Brazil. Shizen aims to be a relevant player in the Brazilian renewables sector, and these 17 projects represent a fivefold growth from our previous undertakings. We invest to make sure renewable energy finds its way to the most people possible, and are confident that creating a 100% renewable powered world is not only possible, but within our reach. "

With the purpose of "We take action for the blue planet", Shizen Brazil will utilize its renewable energy power plant development and construction expertise from Japan to continue to serve the needs of Brazil in order to accelerate the renewable energy transition for a more sustainable society.

*1: "Net-metering" is a utility billing mechanism for distributed energy system owners. With net-metering, consumers are only billed for the difference between the energy consumed from the grid and the energy generated by their own facilities. When the amount of generated power surpasses that of consumption, the surplus can be carried forward to the following month. In November 2015, the Brazilian government revised its laws regarding net-metering, and is facilitating the introduction of renewable energy.
